1. *Cascading Strings (CS)* will wear dressy black clothing unless otherwise specified.
2. *CS* will arrive at the venue no later than 20 minutes before the music is to start to unload, tune and warm-up.
3. Detailed map and directions to the place of engagement must be provided to the musicians, as well as an indication of how much travel time the *CS* should give themselves in order to ensure that they will be at the engagement on time.
4. It is understood that some instruments, particularly string instruments, are extremely valuable and are susceptible to damage when exposed to certain climatic variations, such as rain, direct sunlight and temperatures below 60 degrees Fahrenheit. Therefore the performers must be provided with shelter from rain and direct sunlight and that the temperature must be at least 65 degrees Fahrenheit.
5. *CS* will be afforded a 10-minute break for every hour played.
6. One straight-backed chair without arms will be provided for the violinist. The harpist will provide her own harp bench.
7. Overtime may be requested at the event, to be decided upon solely by the members of *CS* at that time, and will be billed at \$50 per quarter hour, to be paid immediately.
8. A payment in the total amount is due with this contract. Checks may be made out to *Cascading Strings*. A refund may be given upon request within 15 days of the returned contract. After 15 days, no refunds will be given.
9. In the case that *CS* does not perform due to a car accident, severe weather, or medical emergency, the Customer will be given a full refund and *CS* will not be liable for any damages resulting from this failure to perform.
